AN ORDINANCE ESTABLISHING THE TIMES IN WHICH MALT BEVERAGES (BEER) MAY BE SOLD IN THE JURISDICTIONAL BOUNDARIES OF BRACKEN COUNTY ON NEW YEARS EVE

WHEREAS, the Bracken Fiscal Court desires to implement an Ordinance concerning the sale of malt beverages (beer) on New Years Eve of each year but leaving all other times in which malt beverages (beer) may be sold as currently set by statute.

WHEREAS, the Fiscal Court has the authority pursuant to KRS 244.480 to establish the times during which malt beverages (beer) may be sold within its jurisdictional boundaries including sales on New Years Eve of each year.

NOW THEREFORE, pursuant to the authority of KRS 244.480, IT IS HEREBY ORDAINED by the Fiscal Court of Bracken County, as follows:

1. The sale of malt beverages (beer) at all places offering same for sale shall be extended on the night of December 31st to the hour of 1:00 am (of January 1st) of each year for the celebration of New Years Eve.

2. Except for the change set forth in paragraph (1) above relating to New Years Eve, the sale of malt beverages and the sale of other alcoholic beverages shall remain as currently established by statute and shall in no way be changed or altered.

NOW THEREFORE, pursuant to the authority of KRS 244.480, IT IS HEREBY ORDAINED by the Fiscal Court of Bracken County, as follows:

1. The sale of malt beverages (beer) at all places offering same for sale shall be extended on the night of December 31st to the hour of 1:00 am (of January 1st) of each year for the celebration of New Years Eve.
2. Except for the change set forth in paragraph (1) above relating to New Years Eve, the sale of malt beverages and the sale of other alcoholic beverages shall remain as currently established by statute and shall in no way be changed or altered.

Bracken County extends Beer sales until 1:00 AM on New Years Eve. Off: 12/31/09

3. Consumption of alcoholic beverages on licensed premises may not continue for more than thirty minutes after the respective hours above for sales thereof to stop.

4. Penalties: Any person or entity who shall violate any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof, be punished by fines not to exceed \$500.00 or by imprisonment for a term not to exceed six months, or by both such fines and imprisonment.

5. The invalidation of any part of this Ordinance shall not affect the validity of any other part hereof.
