**AN ORDINANCE RELATING TO THE AMENDMENT OF  
CHRISTIAN COUNTY ORDINANCE 2017-01 AUTHORIZING THE  
SALE OF SOUVENIR PACKAGES AND ALLOWING SAMPLING AT ANY  
LICENSED KENTUCKY DISTILLERY ON SUNDAYS IN CHRISTIAN  
COUNTY, KENTUCKY.**

**WHEREAS**, Christian Fiscal Court did approve Christian County Ordinance 2017-01 authorizing the sale of souvenir packages and allowing sampling at any licensed Kentucky distillery on Sundays in Christian County, Kentucky;

**NOW THEREFORE BE IT ORDAINED** by the Fiscal Court of the County of Christian, Commonwealth of Kentucky, as follows:

That Section One of Christian County Ordinance No. 2017-1 is hereby amended to read as follows:

**SECTION 1: SALE OF SOUVENIR LIQUOR PACKAGES AT DISTILLERIES**

- A. Any licensed Kentucky distillery located in Christian County that has a gift shop on its premises may sell souvenir packages of distilled spirits at retail to distillery visitors of legal drinking age, in quantities not to exceed an aggregate of three (3) liters per visitor per day, with the exception of a purchase by a partnership, limited liability partnership, corporation, limited liability company, or other business entity holding an event on the premises of the distillery, in which case the limitation shall be one (1) liter per visitor attending the event.
- B. The sales referenced in provision A above shall be permitted only through the gift shop on the distiller's premises, and only if the distillery is located in wet territory in Christian County.

- C. For Monday through Saturday of each week, the sales referenced in provision A shall be limited, if at all, only by Kentucky Revised Statute or regulation of the Department for Alcoholic Beverage Control; excepting only Thanksgiving Day for which sales shall not be allowed. For Sunday sales, hours of operation shall be limited to the hours of 1:00 p.m. until 6 p.m. prevailing time. The Sunday sales allowance provided herein is a specific exemption to the current law prohibiting Sunday liquor sales in Christian County, Kentucky. The foregoing notwithstanding the Sunday sales, as authorized herein, shall not be applicable to Easter Sunday or any Christmas Day which may fall on a Sunday.
- D. Souvenir packages sold pursuant to this ordinance shall not be sold for consumption on the premises of the distillery, and bottle or package seals may not be broken until the purchaser is off the distillery premises.
- E. Distilleries possessing a valid non-quota type 2 license issued pursuant to KRS 243.084 shall be able to exercise such license according to the hours specified in Section 1, subsection C, of this Ordinance.

All provisions set forth in Christian County Kentucky Ordinance 2017-01 shall remain in full force and effect as adopted on March 28, 2017, excepting only those provisions amended by the terms and conditions specifically set out herein.



**WHEREAS**, Christian Fiscal Court did approve Christian County Ordinance 2017-01 authorizing the sale of souvenir packages and allowing sampling at any licensed Kentucky distillery on Sundays in Christian County, Kentucky;



CHRISTIAN FISCAL COURT

ORDINANCE NO.: 2012- 01

**AN ORDINANCE ESTABLISHING HOURS FOR SALE OF ALCOHOLIC BEVERAGES; PROHIBITED ACTS OF SALE OF ALCOHOLIC BEVERAGES**

**BE IT ENACTED AND ORDAINED** that the Fiscal Court of Christian County, Kentucky, as follows:

**Section One:** No person or entity shall do any act authorized by any kind of license with respect to the manufacture, storage, sale, purchase, transport, or other traffic in alcoholic beverages unless that person or entity holds the kind of license which authorizes that act.

**Section Two:** Any holder of a permit from the Commonwealth of Kentucky to traffic in alcoholic beverages shall also be required to obtain a county license to sell or traffic in alcoholic beverages.

**Section Three:** Any person or entity conducting a place of business patronized by the public who does not have a license to sell alcoholic beverages shall not permit the sale or trafficking of alcoholic beverages on the premises of the business.

**Section Four:** All premises located in the unincorporated areas of Christian County, Kentucky for which a license has been granted to sell alcoholic beverages, including malt beverages, may remain open for business on Monday, Tuesday, Wednesday, Thursday, and Friday, from 6:00 a.m., (prevailing time) to 1:00 a.m. (prevailing time) the following day and from 6:00 a.m., Saturday (prevailing time) to 12:00 a.m., midnight (prevailing time).

**Section Five:** No alcoholic beverages, including malt beverages of any kind, may be sold on Sunday from 12:01 a.m. until 6:00 a.m. the following Monday (prevailing time); on Christmas Day, Thanksgiving Day, or during the hours that voting polls are open on any regular, primary or special election day.

**Section Six - PENALTY:** Any person found in violation of this Ordinance shall be deemed guilty of a misdemeanor and fined not more than \$500.00, imprisoned for not more than 30 days, or both.

**APPROVED** on first reading on the 10 day of JANUARY, 2012.

**ADOPTED** on the second reading on the 24 day of JANUARY, 2012.
